The purpose of this Market Information Circular (MIC) is to announce FX Options Margin Levels.

**Subject: Options - ISE FX Options Margin Levels**

The ISE has determined applicable margin levels for each currency product pursuant to ISE Rule 1202(d), which requires the Exchange to review five-day price changes over the preceding three-year period. The margin level is set at a level that would have covered price movements during the review period at least 97.5% of the time (“confidence level”). The ISE will review these margin levels each quarter, in January, April, July, and October.

Upon completion of its review, ISE FX margin levels for the trading period January 17, 2012 – April 16, 2012, will be as follows:
